Decision Taken: The proposal of Rs. 50 lakh was not confirmed by the Hon'ble Board rather directed the Principal i/c to follow the steps as below-

- a) To calculate the actual liability for the 2 employees going to be retiring in coming couple of months and only that much of amount should be transferred.
- b) To collect the statements of balance amount required by LIC to be paid from IHM, Gwalior till the retirement of all eligible pension holders with their timely payment of dearness relief and other obligations.
- c) To consult an experienced Chattered Accountant or Actuarial service provider for the recalculation of future pension liabilities of IHM eligible employees.

With the above documents only the matter has to be represented before the Board once again.
